## Report on the Webinar on Trade Policy

The Economics Association, Sri Venkateswara College organized a symposium on "TRADE POLICY IN INDIA: TREND STRATEGIES AND PROSPECTS" on 7th May, 2022 over Microsoft Teams. With an enthusiasm to learn something new, the session kicked off.

Before initiating the session, Mahek Gupta, a member of Executive Council of the Economics Association talked about the glory of Economics department and the Economics Association of Sri Venkateswara College and the legacy it carries. Then she introduced the speakers for the day who were:

**Dr. Badrinarayan Gopalkrishnan** (Head, Trade, Commerce & Strategic Economic Dialogue NITI Aayog, GOI)

**Sri Vishnu Dasgupta** (Associate Researcher & Policy Analyst in International Trade Policy, NITI Aayog, GOI)

**Ms. Sugandha Huria** (Assistant Professor, IIFT)

It was then taken over by Dr. Brahma Reddy. He welcomed the guests and then introduced the topic of the session. He explained that the reason for choosing this topic was that a new trade policy of India is expected this year. Then he dugged into the history of India's trade policy and gave a gist of the targets and changes in trade policy in 2015. He further elaborated the five phases of India's trade policy and how the volume of India's international trade have seen a tremendous rise since independence.

In the second half of the webinar, we were enlightened about the ever-evolving nature of international trade by three panelists. The presentation commenced by highlighting the early years of international trade after the signing of the GATT agreement in which countries only used to trade in finished goods. Trade was defined by the technology differential which inadvertently led to maximum trade between different countries.

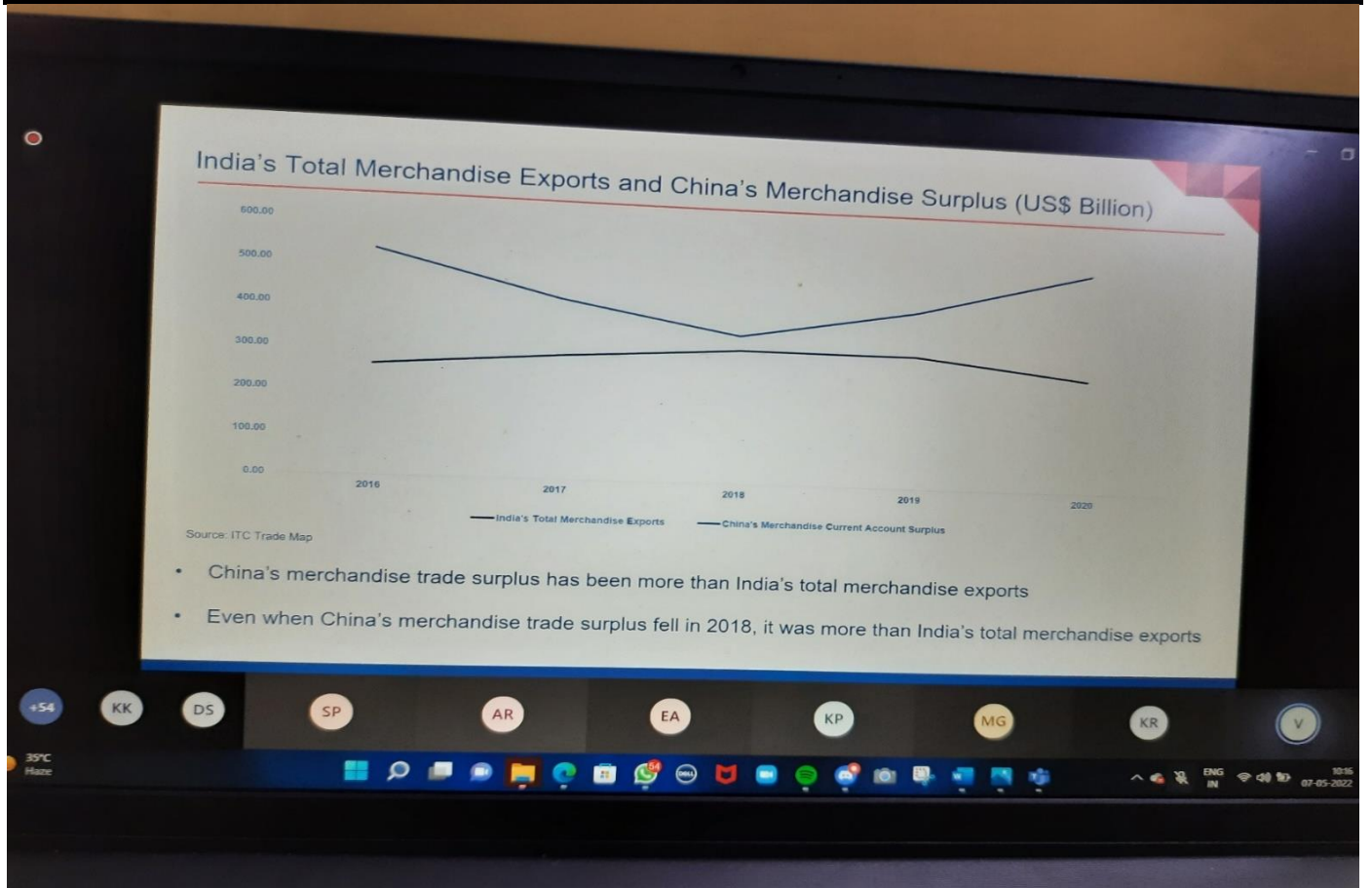
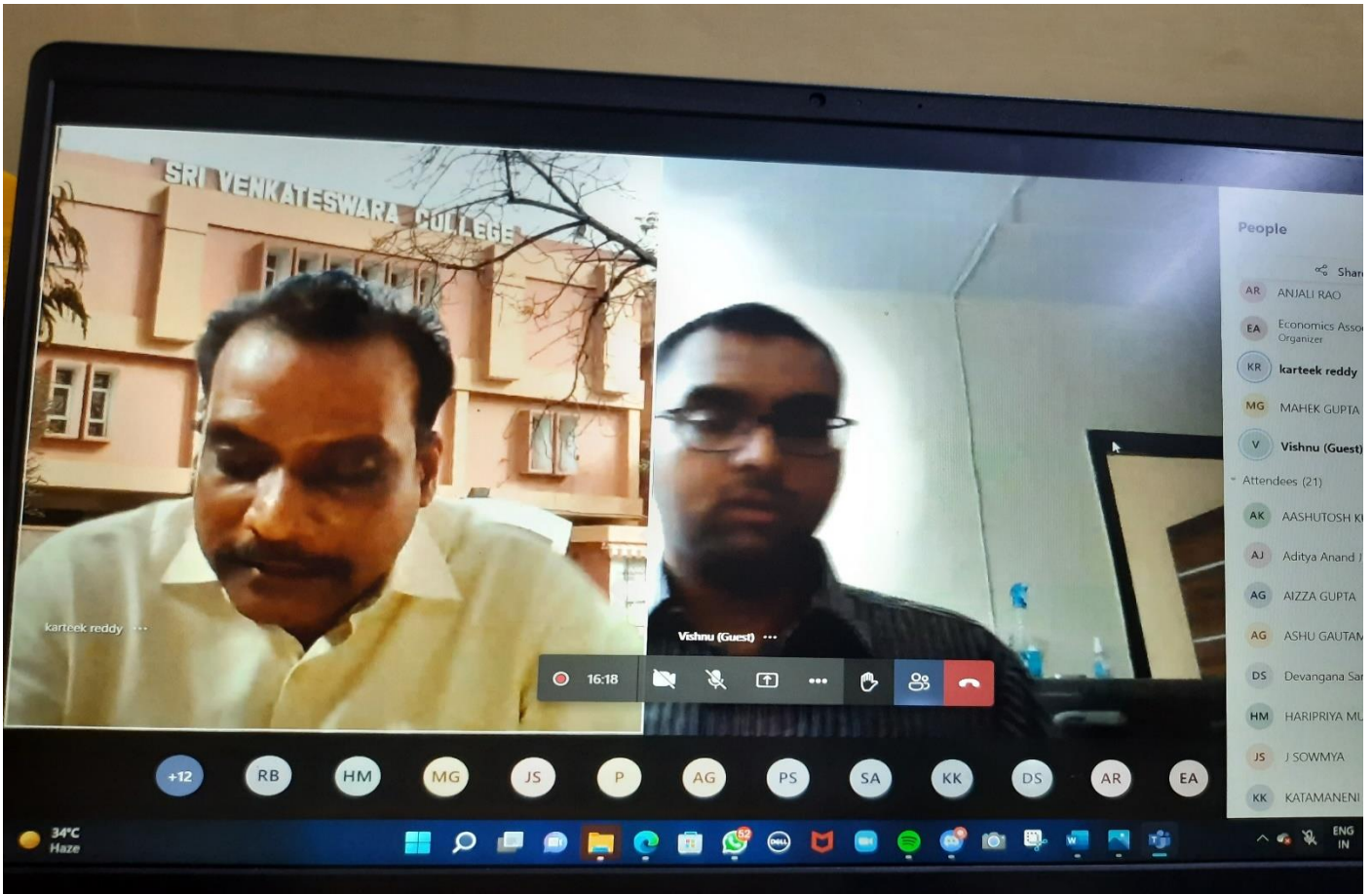
This was contrasted with the present scenario in which more than 60% of the worldwide trade pertains to intermediate goods which often act as inputs for other products. We then talked about how trade and Foreign Direct Investment (FDI) have become complements of each other as opposed to supplements in the past. Post 60s, the dominance of intra-industry trade became ostensible owing to a variety of factors like reduced transport and communication costs as well as rise of complex global supply chains.

There was also a use of a scatter plot diagram to show a positive link between FDI and trade and how India is performing below its potential. In the last leg of the webinar, they explained the growing interlinking of trade, technology, services and FDI and also how centralization of various departments handling them can bring about a policy coherence. It was concluded by highlighting how the growing working age population of India makes it an indispensable part of international trade specially on the consumption side.

After the webinar, the speakers went through a round of Q&A with the students and the teachers ranging from topics such as SEZs to trade agreements.

Dr. Brahma Reddy Sir delivered a vote of thanks to both the speakers for covering such dynamic topics and explaining them in a coherent way. All in all, the webinar was a grand success.

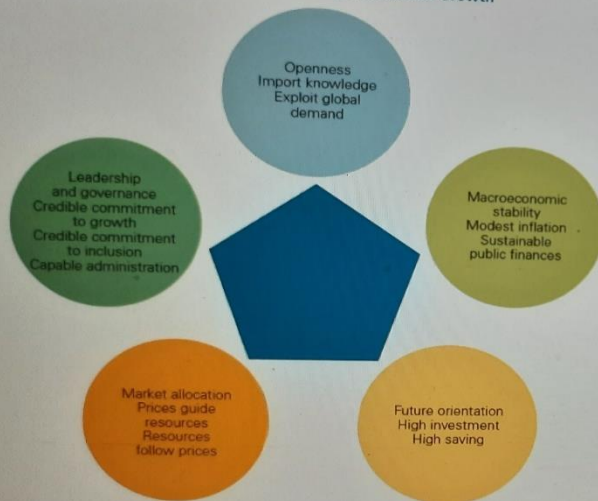

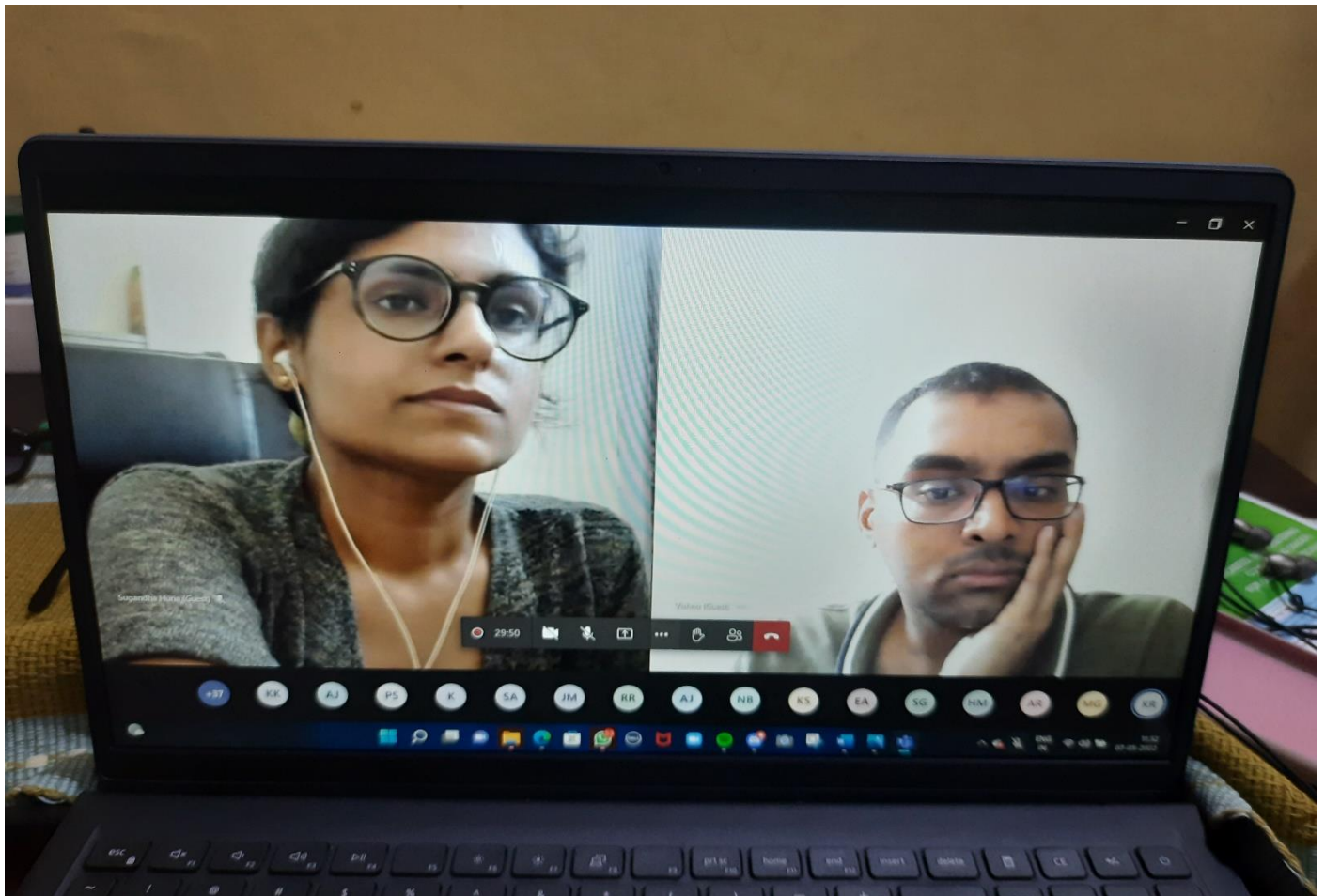
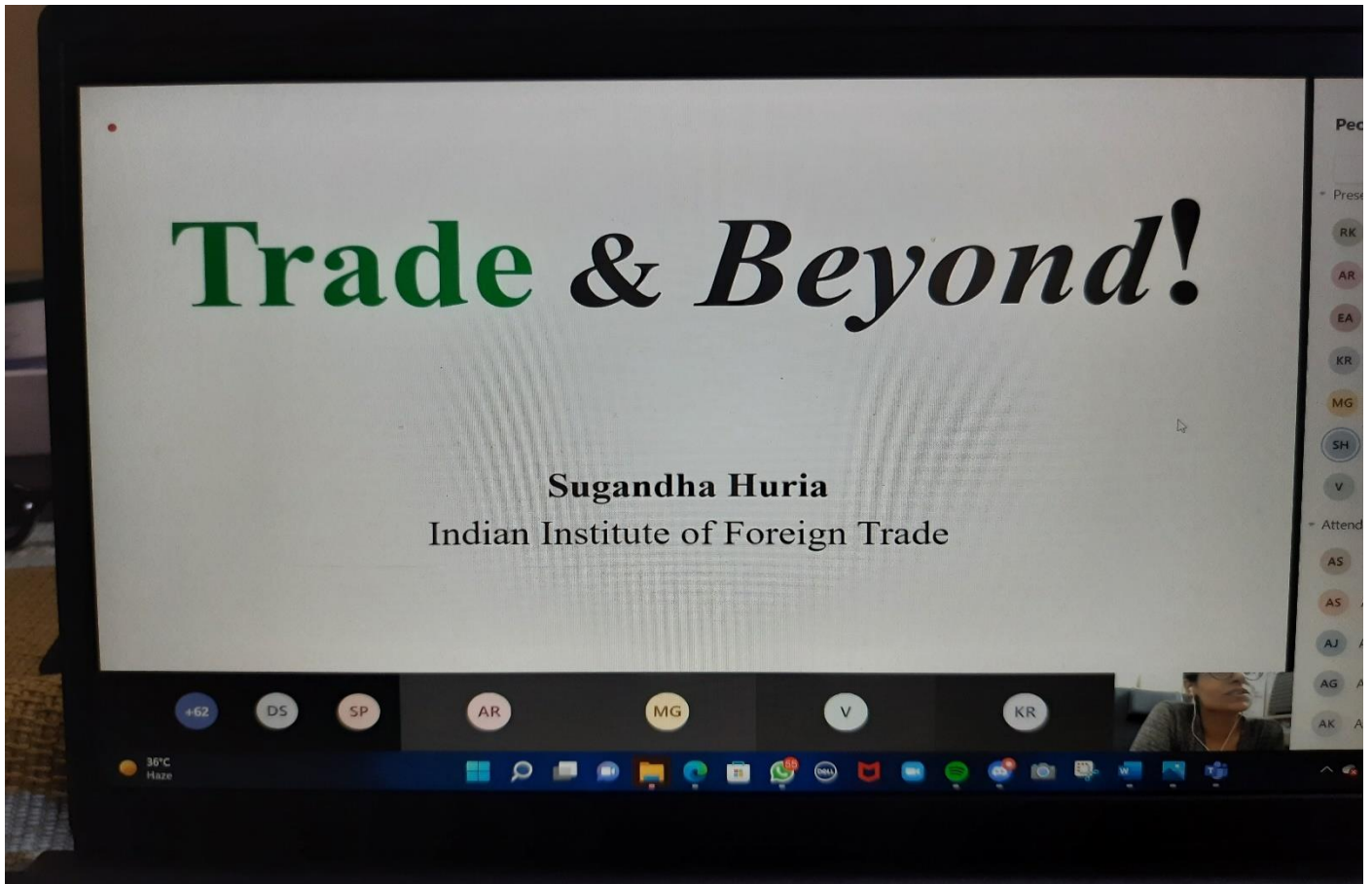
Figure 2 The Common Characteristics of High, Sustained Growth
