3. Event Report

The Economics Association, Sri Venkateswara College organized a webinar on "Cryptocurrency and Metaverse" on 26th February, 2022 as a part of its annual fest Blisspoint'22 via MS Teams.

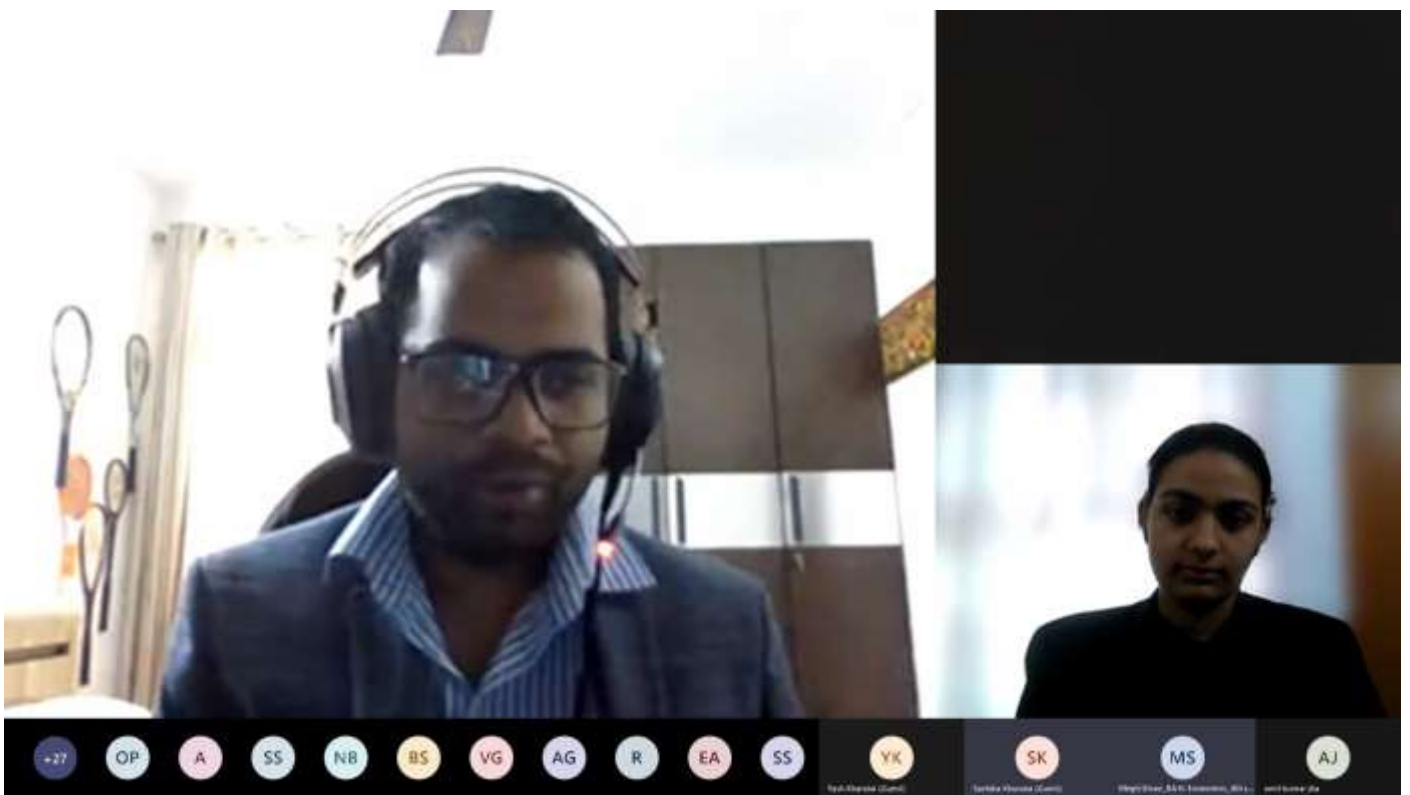
The keynote speaker for the session was Mr. Kartik Hegadekatti, serving as the Deputy Secretary, Department of Personnel and Training (PMO), Govt. of India. He has authored 11 books and 45+ research papers on a wide variety of topics. He talks about subjects such as energy, future, blockchain, cryptocurrency and infrastructure. The second panelist was Mr. Siddharth Dalmia, strategic and legal consultant specializing in blockchain technology. He currently runs digital asset management as a service company.

Before initiating the session, the President of the Association, Navya Jindal, talked about the glory of Blisspoint and the legacy it carries. Naman Kapoor, Vice President talked about Digital Economics - theme for this year's Blisspoint. Araba Kongbam, General Secretary, introduced the speakers for the day.

It was then taken over by Dr. Kartik. He explained Quantum Supremacy and its relation with Blockchain technology. He then talked about Blockchain technology and its aspects in great detail. He gave insights on topics like Distributed Ledger Taxonomy, Bitcoin, sectors affected by Blockchain technology and Cryptocurrency. According to Sir, Blockchain as a technology can be used in plasma propulsion, self-driving cars, vertical farms, Q-Computing, Robotics etc. Some experts are of the opinion that we've entered a crypto bubble that is likely to burst. He further mentioned that Blockchain is encouraged by the Indian government whereas cryptocurrency will be regulated. He then explained the difference between cryptocurrency and fiat money. Later, Dr. Kartik participated in an interactive QnA session. At the end of our discussion with the keynote speaker; Mr. Amit Jha, Faculty Advisor, proposed a vote of thanks to Dr. Kartik for the insightful session.

Moving forward, Joint Secretary, Yash Khandai, introduced the second speaker for the day, Mr. Siddharth Dalmia. Mr. Dalmia started his presentation by taking into account the importance of Digital Assets. He further explained Digital Assets through the lens of legal procedures by stating the presence of two major contracts which include Traditional Contracts and Smart Contracts. The Traditional Contracts include contracts made by human intervention and are highly susceptible to manipulation. On the other hand, Smart Contracts, as the name suggests, are an intelligent way of signing contracts which include little to zero human intervention as the decision making lies in the hands of a computer indicating a foolproof contract being formed resistant to manipulation by either parties. Sir linked the concepts of economics, information technology and legal studies to create an amalgamation of these fields and emphasized on its significance for the future growth of economies. After finishing his session, Mr. Dalmia interactively engaged with the students and resolved their doubts, and with the end of this, the curtains of the second and final day of Blisspoint 2022 rolled down.
