Concession/Waiver of Fees

The candidates admitted provisionally to any undergraduate course in the college, under the following categories, are directed to submit following mandatory certificates/documents at the time of admission to Undergraduate Courses for availing Fee Waiver/Fee Concession as per rules :-

1. PWD (Persons with Disabilities) :- Disability Certificate issued by the Competent Authority. Consequent upon amendment to Ordinance X (4) of the University, the following provision has been added after Sub-clause 2 of Ordinance X (4) of the said Ordinance:-

"Provided that the Persons with Physical Disabilities shall be waived off all the fees payable including the Examination fee and other University fees, except Admission fee, subscription towards Delhi University Students' Union and Identity Card fee for pursuing under-graduate, post-graduate or other courses in the University or its Colleges."

In pursuance of the above, the students with physical disabilities pursuing various courses of study in the Faculties, Departments, Centers, and Institutions / Colleges of the University shall be exempted from payment of fees, including examination fee and other University fees, except Admission fee, subscription towards Delhi University students' Union and Identity Card fee.

In pursuance of the Executive Council Resolution No. 50 dated 03.11.2012, it is notified that the students with physical disabilities residing in different Hostels / Halls of the University are exempted from payment of all hostel fees and charges except refundable caution fee and the mess fees. The Persons with Physical Disabilities students shall pay 50% of the Mess fee and the remaining 50% of the Mess Fee-in respect of the PwD students is being met by the University. Similar norms are to be adopted by the Colleges in respect of PwD Students residing in various hostels of the Colleges.

2. Scheduled Caste (SC)/Scheduled Tribe (ST) :- SC/ST Certificate (in the name of Candidate along with the Income Certificate issued by the Competent Authority for concession/Waiver of Fee i.e. Admission and Tuition Fee testifying that their parents are not Income Tax Payees vide university letter number SPLC/Fee Exemp/SC/ST/2015-16 dated 09th September, 2015 received from the Assistant Registrar (Special Cell), University of Delhi, Delhi.

3. Children of Sri Venkateswara College Employee (s) :- Employment Certificate issued by the college testifying that their parent is Sri Venkateswara College employee(s).

4. The Tibetan candidates are exempted from paying University Registration fee and additional fee payable to the college/Department as Foreign Candidates vide university letter number DYDFS/FSR/2973 dated 09th July, 2014 received from Deputy Dean (Foreign Candidates Registry), University of Delhi, Delhi.
