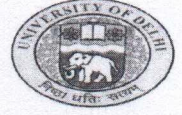

Note:-

1. The term of office of the members (excluding students' representatives) of the ICC shall be for a period of upto three years ending before/on 08th April, 2024. However, one-third of the members of the ICC may change every year.

Term of the student members/representatives to the ICC

Under regular circumstances, the term of the Students Representative to the ICC is for a period of one year or till the result of the subsequent election is declared in the category or till he/she is a bonafide student of that course for which he/she was admitted, whichever is earlier, provided that

- a) The student representatives shall not represent in the ICC from the end of their examination (in May) till the commencement of the subsequent academic session; and
 - b) The Student Representatives to the ICC shall, in no case, have a term beyond one year.
2. The members appointed from amongst the non-government organizations or associations shall be paid such fee or allowances for holding the proceedings of the Internal Committee, by the Executive Authority as may be prescribed.
