All the members of the staff (Teaching and Non-teaching), are hereby notified that in pursuance of Delhi University notification no. Estab. II (i)/23/CGHS/2023/903 dated 20<sup>th</sup> July 2023 (copy attached) w.r.t. mandatory Health Centre Contribution (HCC) for availing medical reimbursement by the staff (Teaching and Non-Teaching) w.e.f. the 1<sup>st</sup> July, 2023, @ as is applicable in case of CGHS beneficiaries of GOI as per the pay levels of 7CPC, it is mandatory to subscribe monthly as per the 7cpc pay level rate applicable for the CGHS beneficiaries to avail medical reimbursement facility both in case of OPD or IPD medical expenses w.e.f. 1st July 2023.

2. In view of the above, it is further informed that all the medical reimbursement claims for the treatment on or after 1st July 2023 will not be received for processing in case of the staff members not making the monthly subscription being deducted from the respective salary of every month.

3. Further, the deduction is effective from the salary of July 2023 by default.

4. However, any staff who do not wish to avail medical reimbursement facility may intimate the Principal office ([principal@svc.ac.in](mailto:principal@svc.ac.in)) with CC to Section Officer-Accounts ([soaccounts@svc.ac.in](mailto:soaccounts@svc.ac.in)) through mail or otherwise in writing immediately, to avoid such deduction towards medical subscription.
