NOTIFICATION

This is to inform all that the ERP portal shall be reopened to select GE, VAC, SEC, and AEC options, exclusively for SEM II, IV, and VI students who could not fill their preferences in the earlier window. The window shall remain open from 11th February 2025 to 14th February 2025.

The students filling out the form may note the following:

1. There is a common form for the selection of SEC, VAC, AEC, and GE options.
2. Check the eligibility/pre-requisites for the courses and apply only if you are eligible/fulfill the prerequisites for the course.
3. The students must go through the detailed instructions given on the ERP for GE, VAC, and SEC courses before filling in the option form.
4. Three distinct paper options must be selected in order of preference for SEC, VAC, and GE papers.
5. Students who filled in the form completely and were allocated GE, SEC, VAC, and AEC papers will not be allowed to fill the form again.
6. SEC and VAC papers are filled on first-cum-first serve basis. So, limited seats are available for these courses. The option shall close as soon as the required seats are filled.
7. **Do not apply for a VAC/SEC that you have already studied in the previous semester/s.**
8. A student who intends to make a minor discipline must ensure that he/she takes **three compulsory** GEs of that department apart from four other GEs offered by such department in the GE pool. **For choosing GE courses, please go through the website notification regarding Mandatory GEs for a discipline using link:**

9. Students admitted in the Academic year 2022-23 and 2023-24, are allowed to study mandatory GEs of the discipline/department they plan to make as a minor, irrespective of the pre-requisites prescribed for these GEs.
10. For Choosing GE/DSE course, it is important that a student also goes through the Website notification regarding modalities of making a minor discipline, using the link:

11. Students must not opt for any GE paper if the syllabus of the GE has more than 30% similarity to any DSC/DSE/GE paper studied so far or to be studied in the following semesters as part of their curriculum. The student may consult their respective Teacher-in-Charge to seek clarifications in this regard. The following amendment to ordinance V, dated 16.12.24, issued by the University of Delhi is also relevant:

A student who wishes to make a non-core discipline as a Minor through the Generic Electives (GEs) shall choose to study any GE(s) of such discipline in place of the mandatory GE(s), provided he/she has already studied DSC(s) or DSE(s) or going to study DSC(s) of his/her core discipline(s) which has more than 30% similarity with the mandatory GE(s).
