# PRIME MINISTERS' SPECIAL SCHOLARSHIP SCHEME (PMSSS)

### Undergraduate courses' admissions for the year 2021-2022

This is for information and necessary action by all concerned that the Department of Higher Education, Education Ministry, Govt. of India is implementing Prime Minister's Special Scholarship Scheme for UTs of J&K and Ladakh (PMSSS) students from the academic year 2011. AICTE, being the implementing authority, awards scholarships to the candidates offered admission against supernumerary seats through online centralized counseling process under PMSSS.

In view of the above, all the candidates who have been recommended provisionally by the AICTE for admission to various undergraduate courses available in the College are requested to e-mail all necessary documents as per attached notification number SVC/Admn/2021/P/1707 dated 29 September, 2021. Further, students are requested to duly complete and submit the application forms for ID cards and Anti-Ragging Self Certification (from the candidate as well as their parent/guardian) available on the college website.

It is pertinent to mention here that the candidates who have been provisionally allotted the seat are required to complete the Online Admission Formalities of the college **as per the schedule published by AICTE** positively. The candidate shall mail all the original documents to <u>principal@svc.ac.in</u> within the stipulated period, failing which her/his candidature shall be cancelled automatically and the seat may be allotted to the next candidate, as per rules.

As a special consideration, candidates are allowed to take on-line admission in the college and will have to complete the online joining formalities immediately after giving confirmation of allotted seat as per prescribed rules. However, the requisite fee shall be charged, as per norms. It may also be noted that the academic fee of the candidate would be credited to the mandated bank account of the Institute by AICTE through PFMS as per the scheme guidelines.

The online joining letter will be e-mailed to the candidates after necessary verification of all the documents in due course of time. Please note that all admissions are purely **provisional** and subject to further detailed verification and confirmation by the competent authority.

All concerned are requested to adhere the above guidelines in a time bound manner.
