**STUDENTS UNION ELECTION  
NOTICE**

यह सभी संबंधितों की जानकारी के लिए है कि किसी भी उम्मीदवार को प्रचार के उद्देश्य से मुद्रित पोस्टर, मुद्रित पैम्फलेट, या किसी अन्य मुद्रित सामग्री का उपयोग करने की अनुमति नहीं दी जाएगी, जैसा कि पहले ही अधिसूचित किया गया है। एनजीटी के आदेश (ओए नंबर 402/2015 दिनांक 18 जुलाई, 2016) के अनुसार, उम्मीदवार प्रचार के उद्देश्य से केवल हस्तनिर्मित पोस्टर का उपयोग कर सकते हैं।

यहां यह उल्लेख करना उचित है कि उम्मीदवार महाविद्यालय परिसर में केवल निर्दिष्ट स्थानों (यानी लोकतंत्र की दीवारें) पर ही हस्तनिर्मित पोस्टर का उपयोग कर सकते हैं, जिसे महाविद्यालय द्वारा पहले ही अधिसूचित किया जा चुका है। तदनुसार, सभी उम्मीदवारों को निर्देशित किया जाता है कि वे महाविद्यालय परिसर में उपलब्ध लोकतंत्र की दीवारों का उपयोग केवल हस्तनिर्मित पोस्टर चिपकाने के लिए करें।

उपरोक्त को ध्यान में रखते हुए, सभी उम्मीदवारों से एक बार फिर अनुरोध किया जाता है कि वे महाविद्यालय और दिल्ली विश्वविद्यालय द्वारा तैयार की गई आचार संहिता का पालन करें और सभी दिशानिर्देशों का पालन करें। उन्हें इस आशय का एक वचन पत्र 25 सितम्बर, 2024 (4:00 बजे तक) प्रस्तुत करना होगा कि यदि वे या उनके समर्थक आचार संहिता के नियमों का उल्लंघन करते हैं, तो उन पर महाविद्यालय द्वारा अनुशासनात्मक कार्रवाई की जाएगी, जिसमें अभी और भविष्य में भी चुनाव लड़ने से अयोग्य ठहराया जाएगा।
