**Internal Complaints Committee (ICC)  
(NOTIFICATION)**

In a partial modification vide college notification dated 16<sup>th</sup> February, 2018, already uploaded on the College Website ([www.svc.ac.in](http://www.svc.ac.in)) regarding election of Students Representative to Internal Complaints Committee (ICC), this is for the information and necessary action by all concerned within the stipulated period that :-

1. Because of flower show on 23<sup>rd</sup> February 2018, as well as lack of awareness amongst students regarding ICC elections the last date of filing nominations is being extended to 28<sup>th</sup> February 2018.
2. Reference to CGPA stands corrected as SGPA.
3. No student shall be eligible to contest and/or hold a membership of the above said committee for more than one academic year.
4. The tenure of the Students Representatives **will be for one year.**
5. No Candidate is allowed to propose or second his/her own candidature. Further, no Student/Candidate is allowed to propose or second the names of more than one candidate for the committee.
6. **Further, the contestants should not have failed in the preceding academic year and/or re-admitted in the current year as per university rules.**
7. The candidate shall not have a previous criminal record, **that is to say he should not have been tried and/or convicted of any criminal offence or misdemeanor.** The candidate shall also not have been subject to any disciplinary action by the College/University authorities.
8. **The candidate must be a regular, full-time student of the college. That is to say that all eligible candidates must be enrolled in a full time course, the course duration being at least one year.**
9. The new revised schedule of elections will be posted soon.

**However, other particulars of the above said notification shall remain unchanged.**
