These tasks involve the learner in communication actions that are part of a clear social context and lead to a production and a measurable result.	A student can understand uncomplicated discussions on everyday concepts. He can spot proper names and numbers and can understand the differences between several notions of everyday life. He can understand the essentials of a general interest program in standard language and can understand an informative recording. A student can distinguish proper nouns, notions relating to tense, simple descriptions, verbs, successions of elements and French sounds. He can identify common concepts and can understand most of the part from an interview. He can also spot feelings and opinions.

Students give their point of view on different objects and they justify their choice.
La Production orale	To make students speak the French language with the cultural part and provide the information such as daily life, hobbies, dreams, aims, society, development and stereotypes etc	Students can describe their favourite things to do when they were a kid. They can present past events. They can interact by expressing their opinion on a daily situation. A student can express a feeling and suggest alternatives. He/she can enumerate the advantages and disadvantages a particular thing in order to convince his/her interlocutor. Student can understand the theme of a document on familiar topics given in the course book and then they can present and explain the main points of a personal reflection.
