Eligibility:

Master's degree (with at least 55% marks) in Biochemistry/Biotechnology from a recognized university with two years' of post-qualification experience (for SRF) in the relevant field. And (ii) Scholars who are selected through (a) National Eligibility Tests – CSIR – UGC NET including lectureship or GATE or (b) A selection process through National level examinations conducted by Central Department and their agencies and institutions.


Desirable:

Prior experience with protein purification, recombinant DNA technology and Microbiology practices will be preferred.
