Sir,

This is in continuation to this Department's letter of even number dated 9th August, 2024 (copy attached) on the subject cited above, wherein the Department has requested the State Nodal Agency to take the necessary measures to bring awareness about scheme, PM-USP Central Sector Scheme of Scholarship for College and University students (CSSS).

2. However, it has been observed that the number of applications received under PM-USP CSSS is significantly low. The allocated quota for your state is 6853 but only 1538 fresh applications have been received till date. It would lead to under-utilization of the State quota. Also, for renewal applicants 5970 applications are eligible but only 2599 applicants have applied for renewal.

3. Further, 1020 fresh and 1662 renewal applications are pending for verification at the level of Institute Nodal Officer (INO) and 267 fresh and 734 renewal applications are pending for verification at State Nodal Officer (SNO).

4. In view of above, you are requested to spread awareness about the scheme through online and offline modes of communication. In addition to this, you are requested to expedite the verification of the applications and also instruct the INOs for verifying the applications prudently and on timely basis, to avoid the last minute rush.
