सूचना / NOTICE

All the students of first-year undergraduate courses of the college who are desirous of claiming attendance relaxation under **NCC/NSS/ECA/Sports/other Co-curricular activities** may note the following in continuation with the office order dated 12.08.24:

1. Take **participation-cum-permission slip** from the college administration. The same should be countersigned and verified by the convenor of NCC/NSS/ECA/Sports/co-curricular society. **The signed slip should be shown by the students to all faculty members involved in taking his/her theory/tutorial/practical classes latest by 24th December 2024** to earn benefits in the attendance component of IA.
2. The student should finally submit this participation-cum-permission slip along with relevant proofs to the concerned convenor, a counter foil of the slip to the dealing assistant in the office and preserve a photocopy of the same for record purpose.
3. Only students representing college/university in the forementioned categories shall be entitled to this benefit. No compensation shall be given for any individual participation.
4. **Medical cases**
 - a. The student claiming relaxation under medical case, should submit the medical certificate and other relevant reports in the office of the **principal latest by 31.12.24.**
 - b. These documents shall be verified by the medical officer of the college and submitted to screening committee on **2nd January 2025.**

- c. Students may note that the college notification dated 12.08.24 clearly states that medical certificates need to be submitted by the student **not later than 10 days** upon rejoining the college.
