TOPIC/SUBJECT OF THE ACTIVITY	"The p-value Plunge" - Consulting Case Competition
OBJECTIVES	The objective was to plan and execute a dynamic case competition to allow students to demonstrate their statistical acumen, strategic thinking, problem-solving skills, and ability to work collaboratively in navigating intricate real-world situations. In this competition, students immersed themselves in a simulated environment and crafted innovative solutions to tackle the challenges presented.

METHODOLOGY	Stage 1: 24-Hour Case Marathon - The registered participants were provided with a case problem. They were tasked to devise and submit a solution to the case problem within 24 hours. Stage 2: Offline Presentation - The shortlisted participants were invited for the Final Offline Presentation round at Sri Venkateswara College to present their case solution to the panel of judges.

Event Schedule


The event was organized with the aim of creating a platform for students to showcase their statistical acumen, strategic thinking, problem-solving skills, and ability to work collaboratively in navigating complex real-world situations. The event was designed as a dynamic case competition where registered participants were given a simulated environment to work in and craft innovative solutions to tackle the challenges presented.

The event was divided into two stages. In the first stage, the 24-Hour Case Marathon, registered participants were given a case problem regarding the current situation of the Indian Domestic Aviation Industry and were tasked to devise and submit a solution within 24 hours. This stage was intended to test the participants' ability to work under pressure and come up with creative solutions to real-world problems.

In the second stage, the Offline Private Presentation Round, the shortlisted teams were invited to present their case solution to a panel of judges at Sri Venkateswara College. The panel included Mr. Tanishq Handa, a distinguished industry professional from a leading Management Consulting firm- McKinsey & Co. This stage was intended to test the participants' ability to articulate and present their ideas effectively.

The event spanned over four engaging days and saw participation from 100+ registrants representing diverse colleges and universities pan India. The event provided excellent networking opportunities and enabled participants to discuss insightful and unique solutions to the real-world inspired case problem in the Indian Aviation Industry.




