(For General/EWSs/OBC/SC/ST/KM Category Students)

The total amount payable annually (excluding examination fee) at the time of admission to various First Year Undergraduate, Postgraduate and Professional/Vocational Courses during the academic year 2024-2025 is as follows:-

7.	One Year PG Diploma in Bio-Chemical & Molecular Technology.	18,000 (PA) (To be paid in Two Equal installments).
8.	One Year Certificate Course in TTM.	25,000/- (PA) (To be paid in Two equal installments).
9.	Foreign Language (German, French, Mandarin (Chinese), and Spanish : Part-Time) Courses.	17,000/- each language course.

Note:-

1. It is pertinent to mention here that the Examination Fee for **M. Sc. courses** depends on number of Theory and practical papers opted by the candidate and fee shall be charged accordingly.
2. No Examination Fee shall be charged from the candidates belonging to the **Persons with Benchmark Disabilities (PwBD) categories**, as per university rules.
3. The candidates admitted provisionally to any undergraduate course in the college, under the following categories, are directed to submit following mandatory certificates/documents at the time of admission to Undergraduate Courses for availing Fee Waiver/Fee Concession as per rules :-
 - i. **PwBD (Persons with Benchmark Disabilities):-** Disability Certificate issued by the Competent Authority. Consequent upon amendment to Ordinance X (4) of the University, the following provision has been added after Sub-clause 2 of Ordinance X (4) of the said Ordinance:-

“Provided that the Persons with Physical Disabilities shall be waived off all the fees payable including the Examination fee and other University fees, except Admission fee, subscription towards Delhi University Students’ Union and Identity Card fee for pursuing under-graduate, post-graduate or other courses in the University or its Colleges.”

ADMISSION FEE STRUCTURE
(For General/EWSs/OBC/SC/ST/KM Category Students)

In view of the above, the students with physical disabilities pursuing various courses of study in the Faculties, Departments, Centers, and Institutions / Colleges of the University shall be exempted from payment of fees, including examination fee and other University fees, except Admission fee, subscription towards Delhi University students' Union and Identity Card fee. In pursuance of the Executive Council Resolution No. 50 dated 03.11.2012, it is notified that the students with physical disabilities residing in different Hostels / Halls of the University are exempted from payment of all hostel fees and charges except refundable caution fee and the mess fees. The Persons with Physical Disabilities students shall pay 50% of the Mess fee and the remaining 50% of the Mess Fee-in respect of the PwBD students is being met by the University. **Similar norms are to be adopted by the College in respect of PwBD Students residing in the hostels of the College.**

- II. **Scheduled Caste (SC)/Scheduled Tribe (ST) :-** SC/ST Certificate (in the name of Candidate along with the Income Certificate issued by the Competent Authority for concession/Waiver of Fee i.e. Admission and Tuition Fee testifying that their parents are not Income Tax Payees vide university letter number SPLC/Fee Exemp/SC/ST/2015-16 dated 09th September, 2015 received from the Assistant Registrar (Special Cell), University of Delhi, Delhi.
- III. **Children of Sri Venkateswara College Employee (s):-** Employment Certificate issued by the college testifying that their parent is Sri Venkateswara College employee(s).
- IV. The **Tibetan candidates** are exempted from paying University Registration fee and additional fee payable to the college/Department as Foreign Candidates vide university letter number DYDFS/FSR/2973 dated 09th July, 2014 received from Deputy Dean (Foreign Candidates Registry), University of Delhi, Delhi.
- V. **Foreign Candidates Registration Fee is 200 \$ extra** in addition to the above fee for the respective courses.
- VI. **Rupees 500/-only** Caution Deposit is refundable.
