SVCSU & DUSU Elections (2026-2027)
Instructions For the Nomination Paper(s) & Affidavits

1. Download the nomination form, Affidavit, Code of Conduct, Constitution of DUSU, decision of Hon'ble Supreme Court of India regarding Students' Union Election "*University of Kerala v. Council, Principals, Colleges, Kerala and others*" (Lyngdoh Committee Recommendations), Hon'ble Delhi High Court orders in WPC 7824/2017 "*Prashant Manchanda v. Union of India & Ors* (Defacement Case) & WPC No. 13538/2024 "*Akhilesh Kumar Mishra & Ors. Vs University of Delhi & Ors., Delhi Metro Rail (O & M) Act 2002, Prevention of Damage to Public Property Act 1984, The Delhi University Acts & Statutes, The Delhi Prevention of Defacement of Property Act, 2007, Hon'ble National Green Tribunal Order in O.A. No. 402/2015 Nitin Chandran Vs Union of Indian & Ors. and the Notification DU/124/LEGAL6272(17)/2025/2377 dated 08th August, 2025 issued by the Registrar, University of Delhi from University official website i.e. www.du.ac.in – DUSU Elections 2026-2027 and the College website (www.svc.ac.in) respectively for all the posts.*
2. The Nomination should be filed only on this Form. Nomination filed on any other Form shall be considered Invalid. The Nomination Form should be filled in, signed and certified in all respects. No column should be left blank. **Incomplete Form will be rejected.**
3. **Only those students who pay their admission fees within the stipulated period i.e. on or before 9th September, 2026, as prescribed by the University of Delhi, are eligible to vote or file nominations for the Students Union Elections (SVCSU/DUSU) to be held on 18th September, 2026.**
4. **The Prescribed Nomination Form duly filled in and completed in all the respects are to be put in the Sealed Box kept in the Principal's Office for this purpose on or before 10th September, 2026 till 3:00 PM on any working day.**
5. Withdrawal will be permitted if it is submitted only in writing by the candidate in person with College Identity Card alongwith one government issued Identity Card. **No withdrawal shall be allowed after 12.00 noon on Friday, the 11th September, 2026.**
6. **Every candidate is required to furnish affidavits (in the prescribed formats) duly completed in all the aspects along with the Nomination Paper to the effect that he/she does not have any previous criminal record and has not been subjected to any disciplinary action by the College/University. Further, the contestants should not have failed in the preceding academic year (s) and/or re-admitted in the current year.**
7. The last date for the receipt of Nomination Paper (s) is **10th September, 2026, by 3:00 PM**. However, the **affidavits**, in the prescribed format (as specified by the College/University), **duly completed in all respects, must be submitted positively by 12:00 noon on 11th September, 2026.**
